#### How to Qualify:

- Contestants must submit their initial goal and before picture (See Judging Criteria for photo rules) when they start using Kyäni product(s) to kyani90daychallenge.com during the contest entry period.

- Customers must purchase at least two nutritional or skin care products each month during the promotion period.

**Judging Criteria:** Kyäni marketing staff will choose contest winners solely at their discretion based on the before and after pictures, the qualification criteria outlined above, and provided that the photo meets the following rules.

- Photo must be untouched and unaltered.
- Lighting should be adequate without whiting out sections of the image.
- Angle of photos should be the same for before and after.
- Photos must be in focus and must be a portrait (not landscape) layout.
- Background should be plain and should be well-lit.
- Before and after photos must be taken under the same conditions.
- Touch ups and photo editing including filters are not allowed.

# **Additional Information:**

  The judging periods will take place at the end of March, June, September, and December.
- After each judging period, the 5 Finalists and 10 Honorable mention will be announced.
- At the International Convention, the Grand Prize winner will be selected from the previous year's Finalists.
- Ticket to future Kyäni event to be determined by Kyäni Corporate.
- Airfare and hotel accommodations NOT included for winners.
- Logo Gear package will vary by market.
- Submission form must be completed in full to qualify.
