

EXECUTIVE TRIP

IDAHO FALLS, IDAHO JACKSON HOLE, WYOMING

2023 Executive Trip July 11–16, 2023

Qualification Period: April 1, 2022 - March 31, 2023

This is a one-time reward trip for new Kyäni Diamonds. Qualifiers will enjoy spending time in and around Idaho Falls, ID and Jackson Hole, WY.

Reward Trip Includes

- ✓ Round-trip airfare for the qualified Business Partner and their 1 guest.
- ✓ Hotel accommodations on designated trip days for the qualified Business Partner and their 1 guest (1 room).

- Qualification period: April 1, 2022 - March 31, 2023.

Terms

- The trip is non-transferable, cannot be postponed, and has no cash value.

- Business Partners who attended a previous Executive Trip may attend the trip again at their own expense. The Kyäni Events Team must receive at least a 60-day advance notification of intention to attend. Price and availability are not guaranteed and are subject to change.
- If for any reason or at any time the qualified Business Partner cannot attend the trip, the guest will not be allowed to attend.
- All attendees must be at least the age of 18.
- Moved volumes cannot be used to qualify and are not eligible.
- The interpretation and decision about qualification, eligibility or the rules of the trip by Kyäni corporate are final, and are not subject to review. Kyäni reserves the right to amend the rules of this trip at any time and for any reason.
- Qualifying Business Partners that are a corporation, limited liability company, or partnership, are eligible for one award.
